#### A. News from OCPA

The activities of the Executive Director and of the Assistant Research Coordinator

# A.1 Participation in the African Conference on Human Sciences (Bamako, Mali, 28 June - 1 July 2017)

Lupwishi Mbuyamba, Executive Director of OCPA, took part as a panelist in the work of the first African Humanities Conference, preparatory to the World Humanities Conference scheduled to be held in Liège, Belgium, in August 2017. In addition to the Communication on the Charter for African Cultural Renaissance as a resource for the construction of a contemporary African humanism, he expressed the OCPA's welcome to the project of proclaiming January 24 as the World Day of African Culture to give an interview on national television to draw some conclusions of the conference, indicating possible recommendations and a possible way to follow up the meeting.

Finally, in agreement with the Culture Division of the African Union, the Executive Director informed the participants about the Note Verbale that was sent to Member Sates on the ratification of the Charter for African Cultural Renaissance.

A special mention for this meeting should be made of the audience offered for the participants by the President of the Republic of Mali, His Excellency Boubacar Keita, during which he congratulated the Executive Director of OCPA for the "brio" with which the First Pan African Music Forum was organized in September 2016 in Ségou, the second city of Mali.

# A.2 Meetings with the member institutions of the OCPA Partners Network

On the occasion and on the sidelines of the conference, professional contacts took place with the member institutions of the OCPA network with whom exchanges on joint projects took place and issues of common interest were discussed. This was the case with ACALAN (Bamako), CELHTO (Niamey), IRES-RDEC (ancien CRAC, Lomé), CERDOTOLA (Yaounde). The Executive Diector has also developed new partnerships for expanding the network with academic institutions represented at the conference coming from universities of

Guinea Bissau, from the Mozambique Pedagogical University, from the National Institute of Social and Human Sciences of South Africa and others.

## A.3 Cooperation between the African Cultural Agency and the OCPA

One of the initiatives in this field was the contact taken with the African Cultural Agency (ACA, Bamako), the Director of which, Kassoum Coulibaly, on a mission to Maputo, made an information visit to the OCPA Secretariat on 17 July and indicated his wish to initiate formal cooperation between ACA and OCPA suggesting launching co-action projects in the framework of the Observatory's program. To this end, an exchange of basic documents has been agreed which will be a prelude to a Framework Agreement which will define the nature and modalities of such cooperation.

# A.4 Mozambique: Meeting with the Minister of Culture and Tourism on Major Cultural Projects

In Maputo, on 17 July, the Director of OCPA had an exchange with His Excellency Mr Silva Armando Dunduro, Minister of Culture and Tourism, on the preparation of major international events in the field of art and culture planned in the country in the near future. They agreed to establish, from now on, technical commissions of work with the relevant officials of the Ministry to which the OCPA secretariat will provide technical support.

## **A.5 Arterial - OCPA Cooperation**

In addition to the framework agreement between the OCPA and the Arterial Network, as well as specific cooperation actions such as the co-organization of a workshop on performing arts policy and participation in significant events of each partner. Wishing to have a reference on the work in progress at the OCPA, Arterial had proposed to fill in a questionnaire to which answers were formally given on 10 July. These responses are intended to inform the members of Arterial's network and, in addition, the readers of its newsletter around the world, on the vast field of operation of the Observatory.

# A.6 Closing of the UNESCO-OCPA Research Project on Inter-religious Dialogue

The research project on Intercultural and Inter-religious Dialogue in Africa led to a book published in July 2017 by OCPA and produced by the CIEDIMA printing house in Maputo with UNESCO's financial assistance under the Participation Program.

In addition to the texts of OCPA researchers, this book contains scientific contributions of experts from Mohamed V University of Rabat (Morocco), the University of Legon (Ghana), Cheikh Anta Diop University of Dakar (Senegal), the University of Abomey-Calavi (Benin), the Major Seminary of Bujumbura (Burundi), the National Institute of the Arts of Kinshasa (Democratic Republic of Congo), the Higher Institute of Art and Culture of Maputo (Mozambique) and Thabo Mbeki African Leadership Institute of Pretoria (South Africa).

This publication will soon be put into circulation first of all to the primary recipients, the religious and community leaders as well as the interested national and regional leaders engaged in the political life of the continent.

## A.7 Preparation of the CERAV Workshop in Niamey

Finally, OCPA intensified its contribution to the technical preparation of the Workshop planned from 16 to 18 August 2017 in Niamey, Niger by the CERAV (Regional Center for the Performing Arts-Africa), UNESCO's category-2 center, on the theme of civil society participation in the implementation of the 2005 UNESCO Convention and the African Union's Charter for African Cultural Renaissance. Lupwishi Mbuyamba had several exchanges with the General Delegate of the CERAV, Michel Saba, and with Michel Guérin, Director of the Observatory of Cultural Policies of the French Community of Belgium, a valuable partner and discussed with these interlocutors of the OCPA, upstream, the follow-up of the Workshop in preparation as that of the 1st Scientific Council of the CERAV which was held in July in Bobo-Dioulasso, seat of the Center, and the shared responsibilities that will follow.

#### **A.8 OCPA Publications**

In relation with its research activities OCPA has produced some **25 books and publications** such as a strategy document (2004) and a research programme (2007 and 2010) on the cultural indicators of human development in Africa, a book on "African Musics – New Stakes and New Challenges" (with UNESCO, 2005), the Observatory's 1<sup>st</sup> and 2nd Medium Term Strategy and Plan of Action (2006 and 2011), the Compendium of basic reference texts for cultural policies in Africa (E/F/S, 2006 and 2009), the Guidelines for the Design and Evaluation of National Cultural Policies in Africa (2008 an 2009). The Proceedings of the International Symposium on Policies, Strategies and Experiences in Financing Culture in Africa was published in 2010, the Manual for Training Specialist of Cultural Policy and Management in Africa and the book on the Contribution of Culture to Poverty reduction in Africa were produced in 2013.

Le Kolatier is a platform for meetings and exchanges between actors in the field of music industry, with the aim of providing a good opportunity for emerging African artists and music

groups and for contributing to the development of the African music industry. It includes showcases, workshops, exhibitions and meetings.

It will be held with hte participation of African emerging artists or groups living on the continent lacking international visibility, having at least one album recorded in professional conditions and presenting original works. Groups selected by the International Committee will be informed by June 30, 2017.

#### **B.2** The National Arts Festival (Grahamstown, South Africa)

Held annually since 1974, the National Arts Festival is an important event on the South African cultural calendar, and the biggest annual celebration of the arts on the continent. Starting at the end of June/beginning of July, it runs for 11 days in the small university city of Grahamstown, in the Eastern Cape, 130 km from Port Elizabeth.

The programme comprises drama, dance, comedy, opera, music, jazz, visual art exhibitions, film, student theatre, street theatre, lectures, craft fair and workshops.

The event is open to all regardless of race, colour, sex or creed. As no censorship or artistic restraint has ever been imposed on works presented in Grahamstown, the Festival served as an important forum for political and protest theatre during the height of the apartheid era, and it still offers an opportunity for experimentation across the arts spectrum.

## **B.3 Zanzibar International Film Festival (ZIFF 2017)**

ZIFF is a non-governmental organization established in 1997 to develop and promote film and other cultural industries as catalyst for the regional social and economic growth.

Taking place from 8 to 16 of July, the 2017 edition will be focused on the celebration of the 20 years of one of the greatest film festival in Africa and especially in East Africa. Its central theme will be Finding Joy.

This annual multi disciplinary arts and cultural event is an all-arts affair, with 8 days of local and international discussion panels, workshops, 10 days of screenings of the best local and international cinema and evenings of musical concerts including a Gala each evening.

# B.5 Working group: Towards joint action to fight illicit trafficking of cultural property in the Sahel Region (Dakar,18 - 20 July 2017)

As part of the implementation of the 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property, the UNESCO Dakar Office organized this working group for the identification of joint actions to combat illicit trafficking of cultural property (ITCP) in the Sahel region from 18-20 July 2017 in Dakar.

This meeting aims to present and validate a strategic information document providing an overview of the ITCP in the sub region. Furthermore, these three days of work will result in the mapping of the phenomenon and the development of a concept note, which will be presented to potential financial partners on the last day of the meeting.

#### C.2 Aditional four countries have ratified the Charter for African Cultural Renaissance

As announced last month on the official web site of the AfricanUnion Commission, after Chad, Congo, Ethioia, Mali, Nigeria, Niger, Senegal and South Africa the four additional countries -Angola (6/06/2016), Benin (10/06/2016), Burkina Faso (21/06/2016) and Cameroon (24/05/2017) - have ratified during the past year the Charter for African Cultural Renaissance adopted by the AU Assembly of Heads of State and Government in January 2006.

This Charter shall come into force immediately upon receipt by the Commission of the African Union of the instruments of ratification and adhesion from two thirds of the total membership of the African Union.

For the time being out of the 55 Member States only 12 have ratified it and 31 have signed it. See the list of ratifications at https://au.int/web/en/treaties.

## C.3 Appointment of a New Board of the National Arts Council of Zimbabwe Board

The new 9 member National Arts Council of Zimbabwe (NACZ) board includes individuals are singularly and collectively distinguished and accomplished professionals in their areas of occupation and can contribute to the growth of the local arts industry. The coming in of the new executive is expected to strengthen accountability and operational efficiency of the NACZ.

The NACZ is expected to judiciously play a supervisory and advisory role in the implementation of the national cultural policy and strategy blueprints. The potential of the arts to meaningfully contribute to the national economy and social harmony remains apparent but under explored. The NACZ will have to lead the process of elevating the status of the arts to being a primary human development facilitator.

The Cultural and Artistic Network for Training and the Francophonie, which has become "Renew by Culture, Art and Training", is an organization of a cultural, artistic and literary nature created in June 1999 in N'Djaména.

RECAF's mission is to develop a two-dimensional program for cultural development and subregional cooperation. It brings together cultural actors (artists, places and structures) who share a common action. It is part of an action process integrating the search for cultural identity and the loyalty of a local public, in parallel with the structuring and professionalization of the cultural actors and artists involved. It also offers the opportunity to create, train and / or integrate into networks (national and international), as well as the circulation of artists and their works.

# C.5 Nigeria: Government announces partnership with UNWTO, CNN to boost creative industry

The Minister of Information and Culture, Alhaji Lai Mohammed, announced a tripartite partnership with the CNN and the UN World Tourism Organization (UNWTO) in Lagos at the Creative Industry Roundtable. He said the film industry will be used" as a pivot for the promotion of culture and tourism and for general socio-economic development.

"We are kick-starting the project with a 13-episode production showcasing the various Nigerian cultural resources: beautiful sceneries, wardrobe, fashion, rich music genres, etc.

The tripartite partnership, as well as the MoUs with the Tony Elumelu Foundation, the Bank of Industry and the British Council, were part of the efforts by the Federal Government for accelerating the tansformation of the Creative Industry to a Creative Economy by the private sector.

Alhaji Mohammed reiterated his earlier statement that the Creative Industry is Nigeria's new oil. In fact in the United States, a 2015 report from the National Endowment for the Arts and U.S. Bureau of Economic Analysis shows arts and culture contributed more than 698 billion dollars to the economy, which is about 4.32 percent of U.S. goods and services," he said.

The Minister said the deliberations from the Roundtable would feed into a larger event, the Creative Industry Financing Conference, slated for 17-18 July in Lagos.

The National Centre for Arts and Culture (NCAC) received assistance from UNESCO under the participation Programme (2016-2017) adopted in 1988 to initiate a process to review and reposition The Gambia's Cultural Policy which is dire need of introspection and update.

In all the plans of the government such as job creation, sustained economic growth and national reconciliation, culture has a limitless and central role, he emphasised.

# D.2 Conference of Parties of the UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions (Paris, 12 - 15 June 2017)

During its 6th ordinary session, the Conference of Parties examined several Agenda items, including: follow-up to the Recommendations of the External Auditor's Report; the Secretariat's Report of its activities and the Secretariat's report on the International Fund for Cultural Diversity and its fundraising strategy.

The highlights of the session were as follows

- Operational guidelines on the implementation of the Convention in the digital environment
- Quadrennial Periodic Reports (2015-16); the 2015 Global Report "Re|Shaping Cultural Policies."
- Election of 12 new members to the Intergovernmental Committee (For Africa the members are for 2015 2019: Côte d'Ivoire, Nigeria, Democratic Republic of Congo and Morrocco. For the period 2017 2021 were newly elected: Kenya, Mali and Egypte.)
- Identification of the future activities of the Committee

# D.6 The World Heritage Committee approved the inscription of 21 new sites on UNESCO's World Heritage List (Krakow, Poland, 2 – 12 July 2017)

The World Heritage Committee in its Krakow session inscribed 21 new sites on UNESCO's World Heritage List. It also extended or modified the boundaries of five existing sites.

The new inscriptions bring to 1,073 the total number of sites on the World Heritage List. Angola and Eritrea saw their first sites joint the List during the present session.

As far as Africa is concerned the Committee approved the inscription of the 3 new sites:

- Mbanza Kongo, Vestiges of the Capital of the former Kingdom of Kongo (Angola)
- Asmara: a Modernist City of Africa (Eritrea)
- ‡Khomani Cultural Landscape (South Africa)

In addition the Committe decided the extension of the existing site "W National Park of Niger" (Niger) to W-Arly-Pendjari Complex (Benin, Burkina Faso) and it approved the withdrawal of the Simien National Park (Ethiopia) and Comoé National Park (Côte d'Ivoire) from the List of World Heritage in Danger.

Montréal, June 28, 2017 - Culture Montréal, like the entire Montreal and Quebec cultural community, learned of the Quebec cultural policy renewal project, made public by Minister Fortin. At the middle of the year, 2017 is confirmed as a year of revision of cultural policies for all public authorities. Indeed, a national forum of consultation with the associative cultural community will take place on 5 and 6 September. Citizens are also invited to present their views on the draft policy through an on-line questionnaire on the Ministry of Culture and Communications website. Subsequently, the Minister will table in the National Assembly the new Québec policy on culture, which will include a five-year government action plan with a financial framework. On June 13, 2007, the City Council unanimously adopted the City of Montreal's new Cultural Development Policy entitled, "Creativity and Citizen Culture Experience in the Digital and diversity.

The July 2017 issue first addresses the digital operational guidelines adopted at the Sixth Conference of the Parties to the UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions. It then deals with the initiative to create a new system for observing cultural and linguistic dynamics by the French Language, Cultures and Diversity (DLFCD), Directorate of the Organization internationale de la Francophonie (OIF), the installation on 10 July in Paris of a steering committee of this device, made up of a dozen international experts.
