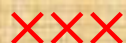

Highlight

First Pan African Cultural Congress (PACC I) Organised by the African Union (13-15 November 2006, Addis Ababa, Ethiopia)

The three-day Pan African Cultural Congress, with the theme Culture, Integration and African Renaissance took place at the headquarters of the African Union in the Ethiopian capital Addis Ababa.

AU Commission Chairperson Professor Alpha Oumar Konare opened the congress, with a call for Africa to promote its culture as the basis for development.

“Africa is facing an identity crisis because we are working without reference to our history. Africa should realize that the foundations of development ought to be based on culture”, he told the delegates.

Quoting professor Ki-Zerbo, Alpha Oumar Konare reiterated that culture in Africa is both a source and a resource. As such, governments and all stakeholders should do everything to promote it. He lamented the lack of resources and political will to support cultural development, saying this affects many aspects of development such as promotion of African languages, protection of intellectual property, film making, literature, theatre, and even the media.

At the same occasion, the Chairperson also recalled the Cultural Charter for the Renaissance of Africa.

Expected outcomes of the Congress consists in a contribution to the renewal of African thought, identity and philosophy as well as to the process of African integration and renaissance; a common understanding and consensus for the creation, production and distribution, production, consumption, commercialisation and protection in the areas of culture and arts; and the establishment and/or strengthening of professional networks.

The Congress was attended by over 250 stakeholders including cultural administrators, educators/ academicians, designers, creators, producers, critics, entrepreneurs, researchers, continental and international inter governmental and non governmental organizations, associations and networks, regional and international cultural organizations and development partners of the African Union. A.1 Workshop on Identity and cultural diversity in conflict resolution and democratization for the African Renaissance, (Johannesburg, 9 – 10 November 2006)

As announced earlier, the workshop was convened in the framework of the research project which has been initiated by the Human Sciences Research Council of South Africa (Pretoria).

Seventeen researchers from Africa, Europe and the USA discussed the relationship between identity, cultural diversity, democratization and conflict resolution in Africa. Papers were delivered on country cases, including Burundi, Cameroon, DRC, Ethiopia, Nigeria, Somalia, South Africa, Sudan and Zimbabwe. Additional papers were read on the work of ACCORD and OCPA. Discussions focused on the nature of the African state and its approaches to nation building, institutional and economic fragmentation in states and regions, and the role of cultural diversity and identity politics in conflict promotion and resolution, peace making and democratization processes.

Country studies highlighted the factors that cause conflict most often relate to struggles for power and unequal access to resources, but that diverse ethnic and cultural identities were used to mobilize supporters from civil society. Issues of culture and identity that were highlighted in the workshop were language, shared values and commonalities, the use of the media for manipulation of civil society perceptions, and the need for a holistic approach to conflict resolution and transformation. B.1 The 8th Session of the OIC Standing Committee on Information and Cultural Affairs (COMIAC),

The Eighth Session of the Organization of the Islamic Conference Standing Committee on Information and Cultural Affairs took place in Dakar, the Senegalese capital, from 13 — 15 November 2006.

The Session examined namely a report on the follow-up of the implementation of the Ten-Year programme of Action in the areas of information and culture. Approved by the Third Extraordinary Islamic Summit of the Organization of the Islamic Conference held in Makkah Al Mukarramah in December 2005, this Ten-Year Programme of Action will be a subject of special attention at the Session as an intergovernmental meeting will be held on the occasion to discuss ways of implementing the programme effectively at the national level.

The COMIAC was established in implementation of resolution of the Third Islamic Summit (Makkah Al-Mukarramah/Taif, 25-28 January 1981).

The Committee is entrusted with: following up the implementation of resolutions adopted by the Islamic Conference on information and cultural affairs; examining all possible means of strengthening co-operation in those fields among Muslim States and putting forth programmes and proposals likely to improve the capabilities of Islamic States in these sectors.

C.1 Conclusions de la conférence chargée de l'harmonisation des politiques culturelle des pays membres de la CPLP

Les responsables en charge de la culture de la Communauté des pays de langue portugaise (CPLP) se sont réunis les 28-29 octobre à Bissau pour définir une nouvelle politique culturelle commune.

La rencontre, qui est la cinquième du genre, a adopté une série de recommandations et de décisions concernant le renforcement de la coopération culturelle entre les pays d'expression de langue portugaise. A cet effet elle a décidé notamment de:

- Créer un mécanisme informel de coordination du suivi des décisions adoptée;
- Confier cette fonction de coordination au Brésil;
- Appeler les Etats CPLP à ratifier, aussi tôt que possible, la Convention sur la protection et la préservation de la diversité culturelle des expressions culturelles et artistiques;
- Appuyer la proposition du Cap Vert concernant la promotion de l'inclusion culturelles effective, tout en demandant une étude approfondie des modalités de la mise en œuvre de cette action;
- Appuyer l'organisation au Brésil embre 2006 du 3e Forum culturel mondial;
- Conclure un protocole sur l'appui de l'OMPI à la CPLP pour la réalisation d'un programme visant le developpement des droits d'auteur et des droits voisins dans les pays de la CPLP;
- Reconnaître l'importance de l'Institut international de la langue portugaise (Instituto Internacional da Língua Portuguesa -IILP) dans la promotion de la langue portugaise et assurer les moyens nécessaires à IILP pour mener à bien son action;
- Renforcer la formation técnico-professionnelle des agents culturels;
- Créer un label culturel CPLP en vue de faciliter la circulation des biens culturels entre les pays CPLP;
- Appuyer la création au Brésil d'un Centre international de l'économie creative (CIEC);
- Accorder une priorité au développement des musées des pays CPLP;
- Approuver la création d'un réseau CPLP de bibliothèques digitales;
- Prendre note de l'organisation, en décembre 2006 au Mozambique, du Iie festival du cinéma;
- Appuyer le Cap Vert dans la présentation de la candidature de deux ensembles historiques (Cidade Velha et l'ex - Camp de Concentration de Tarrafal) à la liste du patrimoine mondial;

D.1 Third Inter-American Meeting of Ministers of Culture (Montreal, 13-15 November 2006)

The meeting was convened to establish a list of priority activities to be carried out over the next two years by the Inter-American Committee on Culture. It took place under the auspices of the Inter-American Council for Integral Development (CIDI, <http://www.cidi.oas.org/>) of the Organization of American States (OAS), in coordination with the government of Canada.

Among other agenda items, a progress report on existing commitments of the Inter-American Committee on Culture was presented by its Chair and the OAS Department of Education and Culture.

During their plenary sessions, the culture ministers and senior authorities considered issues related to the following topics, which are also the areas for priority action:

- Preservation and Presentation of Cultural Heritage
- Culture and the Enhancement of Dignity and Identity
- Culture and the Creation of Decent Jobs and the Overcoming of Poverty, and
- Culture and the Role of Indigenous Peoples

D.2 First extraordinary session of the General Assembly of the States Parties to the Convention for the Safeguarding of the Intangible Cultural Heritage (9 November 2006)

At its first session in June 2006, the General Assembly of the States Parties to the Convention elected 18 members to the Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage. Considering that on 30 August 2006 Zimbabwe was to become the 50th State Party to the Convention, the General Assembly decided in June to "convene an extraordinary session of the General Assembly in order to elect six additional member States of the Committee".

That extraordinary session took place on 9 November 2006 at UNESCO Headquarters, at which time six member States were elected. Consequently, starting from its first meeting on 18 and 19 November 2006, the Intergovernmental Committee is composed of 24 members, the maximum number foreseen by the Convention. From the African continent the Committee includes the representatives of Algeria, Central African Republic, Gabon, Mali, Nigeria and Senegal.

Presently there are 19 State from the African continent having ratified the convention are: Algeria, Burkina Faso, Burundi, Central African Republic, Côte d'Ivoire, Egypt, Ethiopia, Gabon, Madagascar, Mali, Mauritania, Mauritius, Morocco, Nigeria, Sao Tome and Principe, Senegal, Tunisia, Zambia and Zimbabwe.
