## A.1 OCPA at the World Summit of Culture (Abu Dhabi, 8 - 12 April 2018)

Having been unable to travel to the Emirate of Abu Dhabi, the OCPA Secretariat could count on the testimony of Dr. Ribio Nzeza of the OCPA Antenna in the Democratic Republic of Congo, who took part at the second edition of the Abu Dhabi Summit.

This edition, which had a strong participation of 450 experts from 80 countries, was aimed at mobilizing synergies for the capacity building of cultural actors and artists and at strengthening their advocacy force to create platforms for action for enabling them to respond adequately to current development challenges.

The Proceedings of the International Symposium on Policies, Strategies and Experiences in Financing Culture in Africa was published in 2010, the Manual for Training Specialist of Cultural Policy and Management in Africa and the book on the Contribution of Culture to Poverty reduction in Africa were produced in 2013.

## B.2 Meeting of Cultural Actors from North Africa and Sub-Saharan Africa – Summary

As part of the 10th edition of the Abidjan Performing Arts Market (MASA), was held on March 14, 2018, which brought together cultural actors from North Africa and sub-Saharan Africa. This meeting follows those held in Yaounde at the Kolatier, in Rabat at Visa for music and recently in Ségou during the "Festival sur le Niger" in February 2018.

Convened at the initiative of the Network of Professionals and Artists from Central Africa (REPAC), this meeting was chaired by Executive Director of OCPA who, in his opening speech outlined the main purpose of the meeting. Thereafter, LucYatchokeu, President of REPAC, recalled that the launch of the initiative started from the observation that cultural actors in North Africa were more interested in Europe and Asia than in the South of the continent, but they are getting increasingly ready to cooperate with the southern part of Africa. This trend led the previous meeting in Yaounde and Rabat that brought together cultural actors from all regions of the continent.

This intervention was followed by a reminder by Lupwishi Mbuyamba of some historical benchmarks of cooperation between North and South Africa and a debate on the its problems.

Luc Yatchokeu presented the orientations from the Ségou workshop concerning the creation of an information platform on the Arterial Site and the launching of an artistic action program including the establishment of a pan-African project of various activities (exhibition, publications, formats, creations, etc.)

The participants of the meeting also proposed

- integrate North-South dynamics in the celebration of the 35th anniversary of CICIBA;
- Transform existing art markets into itinerant events that promote the mobility of people and the pooling of resources for the organization of different events.
- combine artistic and gastronomic festivals.

In conclusion, Lupwishi Mbuyamba emphasized the importance of breaking the gap between North and South and the need for a gradual change of mentality.

## B.3 Second edition of CultureSummit (Abu Dhabi, 8-12 April 2018)

(By Prof. Ribio Nzeza Bunketi Buse, Catholic University of Congo / University Senghor – Saint-Louis Campus) - Strengthening the capacities of cultural actors and artists and their advocacy force through the creation of a cooperation platform, emerges as one of the main resolutions of this 2nd edition of the Summit organized on the theme "Unexpected

collaborations forging new connections between heritage and innovation, near and far, creativity and purpose".

Launched in 2017 by the Abu Dhabi Ministry of Culture and Tourism, considered as the Davos of Culture, the event brought together nearly 450 leaders in the fields of culture, media and technology from 80 countries to discuss the role of culture in solving current challenges: education and preservation of cultural heritage, economic development, gender equality, the fight against extremism, support to vulnerable communities, etc. This, through a varied programming including panels with high level speakers, workshops, musical, theatrical, photographic performances, as well as guided tours like the Louvre Abu Dhabi Museum.

The presentation of the Cultural Diplomacy Awards was one of the highlights. The winners are Karim Wasfi (Iraqi National Symphony Orchestra), the Prince Claus Foundation for Culture and Development, the EU Youth Orchestra and Emirati artist Hassan Sharif.

## C.1 Africa Music Institute (AMI) on track to improve music education in Africa

The lack of facilities and access to education in Africa are some of the main stumbling blocks in the continent-wide task to professionalise talented individuals in the music sector. Whether it's the absence of knowledgeable teachers to impart essential skills on students, outdated technology or a shortfall in musical instruments, the issues are many and almost impossible to solve without major investment.

The new Institute in Gabon's capital Libreville is trying to renew music education by offering ultra-modern syllabuses and production facilities for bachelor's and master students. The AMI partnered with the world-famous Berklee College of Music with the aim to design innovative coursework that takes into account Africa-specific musical knowledge and culture.

The project is the result of a meeting between Gabon's desire to develop the pan-African educational and cultural sector and the desire of Berklee College of Music to develop a project on the African continent.

The African Music Institute aims to improve the quality of musical education, to develop teacher skills and to promote the economic and social development of the region.

## C.2 ArtMap of Morocco

Established by the Roots Association, Association for Culture, Development, Promotion of Cultural and Creative Industries and Cooperation in Africa), cartography artmap.ma is an inventory listing the structures, infrastructures, artists, operators, professionals of the cultural life in Morocco and the diaspora.

This database aims to

- have a regularly updated inventory, as a tool for cultural spatial planning, accessible to decision makers, for the development of local cultural policies.
- network cultural actors and artists operating in national and international cooperation projects.
- have a statistical tool for setting up and / or evaluating cultural policies.
- support the professionalisation of the artistic and cultural sector.

Artmap.ma is a database gathering professionals from 18 artistic disciplines in 12 regions of Morocco, plus the diaspora. It makes it possible to carry out searches by different criteria (e.g. structure, venue, etc.)

## C.3 Senegal: Report Highlights "Significant Progress" in the Culture Sector

Dakar - The Ministry of Culture has recorded "significant progress", "notorious results" compared to the 2017 exercise, said Thursday in Dakar, in its report, its study and planning unit. The report was presented at the joint 2018 annual review of the Ministry of Culture.

The document shows that the financial volume of literary and artistic property rights collected by the Collective Management Company (SODAV) has increased by 103 million FCFA

compared to the previous year. Regarding copyright "the progression of protected works in 2017 is 1306 compared to 2016".

Performances are also noted in the training of cultural actors with 200 people trained by the director of cinematography (DCI) as part of the training policy in the film industry initiated by the DCI and thirty trained by the management Arts in the regions.

The enhancement of the cultural and religious heritage has had "performances", according to the document of the annual review which notes that "the heritage management has carried out 24 rehabilitation and development works". "This increase is the result of the policy of the Ministry of Culture to work for the preservation and promotion of material heritage", we learn.

The report stresses "the complexity of the contribution of culture to economic and social development. The cultural product has a dual connotation with economic and symbolic value". It recommends to envisage of consultations and partnerships with other ministerial departments.

## C.4 Ethiopia: Ministry of Culture and Tourism

Ethiopian Ministry of Culture and Tourism is the <u>ministry</u> of the <u>Government of Ethiopia</u> responsible for researching, preserving, developing and promoting the <u>culture</u> and <u>tourist attractions</u> of <u>Ethiopia</u> and its <u>peoples</u>, both inside the country and internationally. In doing so the Ministry closely works together with different national and <u>international stakeholders</u>.

It supervises also the <u>Authority for Research and Conservation of Cultural Heritage</u>, <u>Ethiopian Wildlife Conservation Authority</u>, <u>National Archives and Library Agency</u>, and <u>National Theatre</u>.

The Minister, Dr Hirut Woldemariam (Ms) stresses in her message on the Ministry's website that Ethiopia is a country of natural tourist attractions, with <u>nine World Heritage Sites</u>, but the country does not have any coherent tourism development strategy.

The country was the cradle of humankind where humans first began to walk upright, including our ancestors - Lucy (3.4 million years old), Salam (3.5 million years old) and Ardi (4.4 million years old) that are among Ethiopia's rich prehistoric heritage. Ethiopia is also a land of ethnic diversity with more than 80 nations with their languages, cultures and traditions.

# C.5 Burkina Faso: Statements of the Minister of Culture, Abdoul Karim Sango at the National Week of Culture in Bobo Dioulasso 2018

At the opening of the 19th National Cultural Week (SNC), under the theme "Safeguarding cultural values: stakes and challenges", Saturday, March 24, 2018, the Minister of Culture, Arts and Tourism, Abdoul Karim Sango, installed in his new position since February 2018, recalled that this biennale attracts more than 1200 competitors in all five categories and disciplines of the National Grand Prix of Arts and Letters (GPNAL), and nearly 300 000 festival-goers.

He also reminded that outside the competitions the festival includes a varied program: conferences, panel discussions, community village, museum exhibition, arts market, children's initiation, fair, etc.

The mayor of Bobo Dioulasso said that his city, in addition to supporting the biennale by accompanying the artists of the town, made the commitment to make culture, the lever of development of the city.

The success of this cultural week which aims, he said, "to preserve not only the different facets of cultural heritage, but also to support artistic creativity in all regions of Burkina Faso".

The opening of the Biennale of Culture of the Land of the Humankind, according to Minister Sango, to foreign communities living in Burkina Faso, the Burkinabe diaspora and friendly countries, reinforces subregional, regional and international cooperation.

## **D.1 UNESCO Platform of Monitoring Policies for Cultural Diversity**

Through quadrennial periodic reports, Parties to the 2005 Convention systematically collect and share information on policies and measures promoting the diversity of cultural expressions.

Periodic reports offer a unique wealth of data on how public authorities and civil society organizations are working towards the achievement of the Convention's goals around the world.

The purpose of this policy platform is to render this wealth of information transparent and accessible to the general public. A complete set of research categories and filters is available to allow for comparison and support informed policies.

Innovative practices extracted from periodic reports support evidence-based policy making for the promotion of the diversity of cultural expressions, also highlighting the role of culture in the implementation of the 2030 Sustainable Development agenda.

The platform supports information sharing and reinforces synergies between national and international monitoring, featuring policy practices drawn from the periodic reports organized

by key geographic and thematic criteria. With such a tool, stakeholders will be able to better chart progress, identify effective policies and improve existing policy instruments.

# D.2 Fair Cooperation: New Paradigm for Cultural Diplomacy and Arts Management - Annika Hampel

European cultural policy is based on the exchange of artists. It has devoted decades to the objective of encouraging dialogue and enabling cooperative production; especially between the countries of the so-called 'Global North' and 'Global South'. Cultural policy makers and agents in Europe, such as those working in cultural institutions and at the ministries responsible for cultural relations, constantly stress their claims of a 'dialogue of equals'. However, if and how cultural cooperations really are in practice brought to life on equal terms is an open question.

Annika Hampel analyzes the working conditions of partnerships to understand how current artistic collaborations function. She uses five case studies, which offer insights across the spectrum of artistic cooperation, to display the wide range of Indo-German collaborations in the arts and to show how to minimize power relations, promote cultural diversity, and use the potential of cooperative work.

## D.3 The African Film Festival of Tarifa and Tangier celebrates 15 years

In 2018, the African Film Festival of Tarifa and Tangier (FCAT) celebrates its 15th anniversary. These years have served to make the FCAT a real platform for the diffusion of African cinema in the Spanish-speaking world.

The 15th edition will take place from April 27 to May 5, 2018 in Tarifa (Spain) and Tangier (Morocco), so the festival bring us closer to each other, on either side of the Strait [Gibraltar].

According to Mane Cisneros, "the Festival has become a school for experts in African cinema in Spain." ## **D.4 Publication on Cultural Policies for Sustainable Development**

The concept of sustainable development is commonly divided into environmental, economic, social and cultural dimensions. While international actors have declared the importance of culture in sustainable development, the role of cultural policy has remained unclear.

Edited by Anita Kangas, Nancy Duxbury, Christiaan De Beukelaer (Routledge, 2018), this book contributes to a better understanding of the role of culture in achieving sustainability, focusing on the particular roles for cultural policy in this context. Cultural sustainability is conceptualized as the sustainability of cultural and artistic practices and patterns, and to the role of cultural traits and actions to inform and compose part of the pathways towards more sustainable societies. The links between culture and sustainable development are analysed in ways that articulate and contemplate different roles for cultural policy.
