### H.1 UN: 2021 International Year of Creative Economy for Sustainable Development

The celebration of this international year was adopted in 2019 by a resolution of the 74th session of the UN General Assembly, on the basis of a proposal presented by a global grouping of countries, including eight Member States from Africa: Central African Republic, Eswatini, Guinea, Guinea-Bissau, Lesotho, Mauritius, Morocco and Seychelles.

The proposal recognises the need to promote sustained and inclusive economic growth, foster innovation and provide opportunities, benefits and empowerment for all and respect for all human rights.

It also identifies the ongoing need to support developing countries and countries with economies in transition in diversifying production and exports, including in new sustainable growth areas, including creative industries.

It encourages all to observe the year in accordance with national priorities to raise awareness, promote cooperation and networking, encourage sharing best practices and experiences, enhance human resource capacity, promote an enabling environment at all levels as well as tackle the challenges of the creative economy.

# **Editorial**

International news for the month of November 2020 was marked by manifestations of unprecedented violence, the result of systemic religious intolerance. The emergence of the machete civilization and the return of the methods of beheading from another age have exposed the slippages of a civilization in need of landmarks.

In search of the cultural factors of human development in Africa, the Observatory of Cultural Policies in Africa had circulated for three years a joint work of ten African experts, members of its Technical Committee entitled "Intercultural and Interreligious Dialogue: an African experience". This publication is based on the experiences of the 5 cultural regions of the continent and reports on the various attempts and initiatives taken in the spirit of facilitating cohabitation and mutual understanding by trying to focus the eyes on the community of objectives and strategies. nation-building.

In addition to scientific articles, the work relates testimonies from major political leaders' initiatives, in particular the memorable international conference organized in 2015 on the theme of interreligious dialogue by the African Center for Social Prospective, Albert Tevoedjre Institute in Porto-Novo as well as the series of Public Readings organized by the Thabo Mbeki Foundation at the University of South Africa in Pretoria on the demands of global justice as essential skills for legitimate leadership.

The training of professionals, the capacity building of organizers of community and youth activities and the permanent education of community leaders and animators who constitute, among others, means of preventing and curing tragedies of the scale of acts of "barbarism" denounced should find a place in national and regional public policy documents, particularly at a time in history when Humanity jostled by a global crisis which has not said its final word needs to be reassured and to be guided.

# A.8 CERAV

He has also initiated discussions with the United Nations Population Fund with a view to participating actively in the program activities of the celebration of the United Nations International Year for Afro-Descendants. Finally, he supervised a technical meeting at the 2nd Forum des Culturels, in line with OCPA.

### **A.10 OCPA Publications**

In relation with its research activities OCPA has produced some **25 books and publications** such as a strategy document (2004) and a research programme (2007 and 2010) on the cultural indicators of human development in Africa, a book on "African Musics – New Stakes and New Challenges" (with UNESCO, 2005), the Observatory's 1<sup>st</sup> and 2nd Medium Term Strategy and Plan of Action (2006 and 2011), the Compendium of basic reference texts for cultural policies in Africa (E/F/S, 2006 and 2009), the Guidelines for the Design and Evaluation of National Cultural Policies in Africa (2008 an 2009). The Proceedings of the International Symposium on Policies, Strategies and Experiences in Financing Culture in Africa was published in 2010, the Manual for Training Specialist of Cultural Policy and Management in Africa and the book on the Contribution of Culture to Poverty reduction in Africa were produced in 2013. More recently, in 2019, OCPA published with the support of UNESCO a book entitled Intercultural and Interreligious Dialogue: An African Experience as well as the book prepared and published with the support of Africa by 2030".

# **B.** News, events and projects in Africa

#### **B.1 Burkina Faso: African Musical Meetings 2020, unmissable event for music**

Ouagadougou hosted the 3rd edition of the REMA (Rencontres Musicales Africaines/African Musical Meetings) from October 22 to 24, 2020. Its official opening m took place in the presence of the Minister of Culture, Arts and Tourism, Abdoul Karim Sango. the goal of the REMA is making Ouagadougou an essential meeting place for music in Africa.

The 3rd edition saw the participation of around two hundred people from Africa and 16 nationalities. It was placed under the theme: "Music, digital and local economies, how to develop suitable tools?" This theme challenges artists and entrepreneurs in the music sector with regard to the digitization of the world. On the program, panels, trainings and concerts with artists from Burkina Faso and abroad to celebrate music in Ouagadougou which, for 72 hours, was the music capital of the continent, with big names from the music.

### **B.2** Africa: Cultural goods - An illicit trade valued at 10 billion dollars

On the occasion of the 50th anniversary of the Convention aiming to prohibit and prevent the trafficking of cultural property, UNESCO has launched a campaign in Paris called "The real price of art". The objective of the campaign "The real price of art" aims to make the general public who love art aware of the disastrous consequences of this trafficking. UNESCO recalls that the illicit trade in cultural property represents 10 billion dollars per year. "It is fueled by the sometimes highly organized looting of archaeological areas and constitutes a major source of funding for criminal and terrorist organizations. It dispossesses peoples of their history and their identity ", recalled UNESCO. According to the Director-General of UNESCO, Audrey Azoulay, "the illicit traffic constitutes a marked theft of the memory of peoples.

"Raising awareness is necessary to fight against this reality". For UNESCO, it is time to act against the illicit trafficking of cultural property and to reveal the true price of art. "The Real Price of Art" is a campaign that aims to reveal the dark side of behind certain works.

According to the convention concerning the measures to be taken to prohibit and prevent the import, export and transfer of illicit property of cultural property, of 14 November 1970, an international framework is offered to prevent looting, as well as the return and restitution of stolen cultural property. At the same time as broader advances in the fight against illicit trafficking. The campaign is launched ahead of several events, including the meeting of the Convention Committee (October 27 & 28), the first international day against illicit trafficking in cultural property and an international conference in Berlin (November 16-18).

# B.3 Burkina Faso: FESPACO 2021 - Call for films until 15 December 2020

The Pan-African Film and Television Festival of Ouagadougou was initiated with the aim of promoting and enhancing African cinema on the continent. Its 27th edition I scheduled for February 27 to March 6, 2021. The call for films open is until December 15 for both African filmmakers based on the continent and those from the diaspora.

For this edition, the selection has two main sections. The first section, the official competition, is reserved for films by African directors and the diaspora. It has several categories, among

others: feature-length fiction and feature-length documentaries, for a minimum duration of 60 minutes; short fiction and short documentary, films from African film schools, between 3 and 15 minutes.

The second concerns TV series from 2019 and 2020, not yet presented in a previous FESPACO edition. Out-of-competition section will also involve works dating back over two years.

The organization of the 27th edition of FESPACO will be headed by a new Director: Alex Moussa Sawadogo who replaces Ardiouma Soma (2014-2020), admitted to retirement.

Me Mwambayi Kalengayi discusses the social role of African theater In Kinshasa, the Forum des Cultures presents itself as a forum for free expression through which experts in questions on the economy of culture, trainers and mentors of artists as well as artists and cultural operators have had all the time to think aloud, discuss and exchange ideas to revitalize the cultural sector in the DRC. Because, the ideal is to initiate reforms of the fundamental law which will make it possible to make culture an engine of socio-economic development.

Regarding the theme, CRASA approves the deepening of research on the social role of contemporary African theater towards the economy of culture. In perspective and in harmony with the recommendations of this Forum, CRASA is already thinking of reorienting what the role of the theater artist should be in reaction to the problems linked to the development of grassroots communities in the DRC. The participants proposed recommendations for the finalization of the draft law on cultural policy.

# **B.5 Madagascar: Inauguration with great pomp of the restored queen's palace**

Twenty-five years after the fire which destroyed part of Rova, the enclosure of the queen's palace in the capital Antananarivo, the President of the Republic Andry Rajoelina inaugurated on November 6 with great pomp, in front of prestigious guests, the restored Queen's Palace.

A dozen civil society associations have protested against part of the renovation of the site which includes the construction of a colosseum within the walls of the queen's palace. With a capacity of 400 seats, it must host popular and cultural performances on the history of the country. UNESCO was also moved at the beginning of the year by this construction, raising fears for the classification of the upper city of Antananarivo as World Heritage.

The day before, the government had announced the restitution by France of the crown of the last queen Ranavalona III (1861-1917), which was exhibited since 1910 at the Invalides in Paris. The gilded zinc headdress trimmed with ocher and garnet fabric is now on display in the restored royal palace. N.B. In France various senators denounce the fact that this restitution took place without a law having been voted by the French Parliament.

# C.1 Senegal: Second quadrennial periodic report on the promotion of cultural expressions

Senegal presented its second quadrennial report on the implementation of the UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions (2005) ". The document reviews the policies implemented by the State on issues related to the mobility of artists, gender equity and equality and cultural events carried by the territories. The restitution of the report took place at the Grand Théâtre de Dakar in front of the cultural actors, during a ceremony chaired by the Secretary General of the Ministry of Culture and Communication.

The 100-page document highlights the establishment of the Film and Audiovisual Industry Promotion Fund, a section of which supports film professionals participating in festivals and those coming to Senegal for events. cultural. Support for cultural activities with the various existing funds, and cultural events carried by the territories figure prominently in the report.

#### C.2 Mali: Ms. Kadiatou Konaré, Minister of Culture, Handicrafts and Tourism

As announced on October 5, 2020, in the new team of the Transitional Government, the post of Minister of Culture, Crafts and Tourism has been entrusted to Ms. Kadiatou Konaré, daughter of the historian and museologist Alpha Oumar Konaré, former President of Mali, Kadiatou Konaré is an editor, writer and cultural operator, promoter of the Cauris Editions publishing house which aims to create a bridge between Africa and the world through literature.

Holder of a specialized master's degree in publishing management from the Ecole supérieure de commerce de Paris (Escp) in 1997, a diploma from the Institut des Hautes Etudes Economiques et Commerciales de Paris 1995, a diploma in journalism at Columbia University (USA, 1999), she is also a doctoral student at the School of Social Sciences (Ehess, Paris).

The choice of Ms. Kadiatou was supported by Malian cultural actors during the consultations they had with National Committee for the Salvation of the People (CNSP) after the coup d'état of August 18. Ms. Konaré's career raises a lot of hope for the establishment of a good development policy that can help the sector regain its glory. In the government, Ms. Konaré succeeds at the head of the Ministry in charge of Culture, Ms. N'diaye Ramatoulaye Diallo.

# C.4 Senegal: Draft Bill on the Status of the Artist

In the process towards the adoption of the law on the status of the artist, the Association des métiers de la musique du Sénégal organized, from 13 to 15 October, an information seminar on the status of the artist opening up for the majority of them to access the status of employee.

It is therefore proposed to create a one-stop-shop for shows (Gus) for social contributions for all employers of artists and professionals in live or recorded shows (recording, audiovisual).

The one-stop shop for the shows they want is intended to have collective agreements with Ams and other professional organizations that are active in live shows. Employers will thus be able to file contracts with actors in the Gus, which will collect social contributions and transfer them to the various security funds. In the conclusion, the participants agreed on the drafting of specifications and the organization of awareness and information campaigns for a broad membership of the Guichet unique de spectacles.

# C.5 Senegal: 2021 budget of the Ministry of Culture and Communication

The promotion of cultural and creative industries, development of the Communication sector are among the major axes of this program designed under the seal of revival.

2020 will have been a very special year for the field of Culture and Communication. Despite the support of the State, the effect of the coronavirus has accentuated the difficulties within these two sectors which are so strategic in the economic and social development of the country. In the vision of economic recovery of the President of the Republic, notably through the adjusted and accelerated priority action plan of the State (Pap2a), they occupy a fundamental place.

This explains the increase in the Ministry's budget. It goes from 22.8 billion in 2020 to over 26.550 billion FCfa. In the budget, one of the objectives will be to revive the cultural economy.

The Minister indicated, during his visit on November 8, before the Joint Committee of the National Assembly, that the resilience plan for the Culture and Communication sector, is perceived today as an imperative necessity.

For the draft budget, four strategic orientations have been adopted, namely with a view to

- promote the enhancement of cultural and creative industries,
- develop the supervision of the Communication sector,
- enhance the cultural heritage and
- develop the institutional and organizational framework of the culture sector.

It is planned to promote the law on the status of artists, the protection of the copyright and to ensure the financing of structuring projects by the Urban Cultures Development Fund as weel as the enhancement of cultural heritage.

The year 2020 was set to be a major anniver-sary year and a moment of reflection for UNESCO and culture sector – the 15th anniversary of the UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions (2005 Convention), the 10th anniversary of theInternational Fund for Cultural Diversity (IFCD) and the 40th anniversary of the UNESCO Recommendation Concerning the Status of the Artist (1980 Recommendation).

Each represents an important milestone in international cultural policy and creative economy. They embody the global commitment to supporting creativity around the world. Through these instruments, culture and creative industries have been recognized as drivers of inclusive economic growth that can reduce inequalities and contribute to the achievement of the goals of the 2030 Sustainable Development Agenda.

The pandemic, has changed the cultural landscape forever, threatening to undo gains achieved over the last 40 years. On 21 October 2020, UNESCO hosted a special edition of ResiliArt, a unique online event, a high-level panel discussion with artists and cultural professionals from around the world about the past and future of creativity as a pillar of UNESCO's work.

We need to rethink how our society treats creative workers who are as diverse and dynamic as the art they create. COVID-19 has shown us that the arts are "essential work" too. Over the past four decades, UNESCO has advo-cated for improved status of artists and cultural professionals around the world. But there is so much more to be done. Ahead of the Internation-al Year of Creative Economy for Sustainable Development in 2021, the crisis must serve as a turning point. Today, more than ever, we must #SupportCreativity.

Now, more than ever, we need creativity and diversity. In these unstable and uncertain times we need to look to the things that unite us. And for that, we need artists. (Audray Azoulay, UNESCO Director-General)

# **D.2 French MPs approve restitution of cultural property in Benin and Senegal**

French MPs on Tuesday evening unanimously approved a bill restoring to Benin and Senegal cultural property brought to France during colonial times as "spoils of war". The transfer to Benin covers 26 pieces - statues, royal seat, ornate doors in particular - from the "Trésor de Béhanzin" from the looting of the Abomey palace in 1892. They are now in the Quai Branly-Jacques Chirac Museum in Paris. French President Emmanuel Macron had announced their "return without delay" during his trip to Ouagadougou, Burkina Faso, in November 2017, but the process of transfer of property then stalled.

The British Museum has announced plans to help investigate the history of the Kingdom of Benin with a grand archaeology mission and new museum. It will work with Nigerian teams on the creation of a new Edo Museum of West African Art (EMOWAA) and accompanying archaeology project. The plan comes after calls for it to return stolen artefacts to the ancient city.

The museum, which has some 950 Benin Bronzes, has come under particular criticism for its refusal to give them back. The research commences in 2021 and will continue for five years, to look for further royal treasures, and to enable the construction of the museum.

# Nigeria: Netherlands Returns Recovered Ife Terracotta Head to Nigeria - Envoy

The government of the Netherlands has returned a unique terracotta head to the Nigerian Embassy in the Netherlands in compliance with the 1970 UNESCO Convention of prohibiting and preventing illicit import, export of cultural property. The unique and rare terracotta head, believed to be from Ile-Ife in Nigeria, was intercepted by Dutch Customs at Schiphol Airport in 2018 in a package addressed to a Dutch national with forged accompanying import documents. Nigerian authorities confirmed the authenticity of the object and formally requested for its return.
