

Rethinking the concepts and mechanisms of operationalizing the cultural factors of human development

The outbreak of the Coronavirus-19 pandemic in the world in the 1st quarter of the year 2020, will have had the effect, in the field of cultural policies, of forgetting or sidelining (provisional, as we can hope), of the conclusions of the World Forum of Ministers of Culture organized by UNESCO in Paris on November 19, 2019.

However, this meeting - which was not common - had raised major questions, among which one could note a claim concerning the durability of the international cultural conventions voted by the General Conference of the Organization, by proposing that, even when they were ratified by the competent bodies of the various Member States, they can be revised when new issues arise in cultural life.

The venerable participants in the world meeting - around 130 Ministers in charge of culture - certainly did not suspect, at the end of 2019, that the devastation caused by a virus to the entire planet would soon place them in front of these realities which make 'today it is the means and modalities of the resilience of the entire cultural sector that constitute the key issue, de facto relegating to the background the recommendations in favor of "rapprochement" and "dialogue of cultures", And placing in priority the absolute respect of the universal rules of fight against the pandemic which are the observance of "barriers", the wearing of the "mask" and th "distancing"...

Rethinking the concepts and mechanisms of operationalizing the cultural factors of human development will undoubtedly be the subject of a new debate in perspective!

Activities of the Executive Director and members of the OCPA Secretariat

A.1 Implementation of the Call of Segou for 2021, the Year of culture in Africa

On this subject, during the month of March, can be noted

- The official presentation of the concept and project of Industradition by CERDOTOLA on March 5 in Yaoundé
- The organization of a Webinar by the Cultural Observatory of South Africa on IKS (Indigenous Knowledge Systems) as content of the Cultural and Creative Industries Action Plan for South Africa

A.2 Participation in the UNESCO webinar on the impact of COVID 19 on 8 African cities

The Assistant Director-General of UNESCO for the Social and Human Sciences Sector, Ms. Gabriela Ramos, invited OCPA to an online meeting dedicated to the review of the study made in October 2020, in cooperation with Metropolis Canada, on the impact of COVID-19 on 8 African cities. Salma Ait Taleb represented OCPA at the meeting held on March 19 and wrote a report for Ocpa News and the OCPA website. It reads as follows

OCPA attended a virtual session discussing a report released by UNESCO and Metropolis Canada investigating the social impacts of Covid-19 in nine sub-Saharan African cities. The study focused on the following themes: knowledge and fear, safety, financial and health impacts, access to services and trust in institutions during the first and second wave of Covid-19 respectively, through an analysis of a survey that targeted the inhabitants of Dakar, Abidjan, Harare, Maputo, Johannesburg, Freetown, Sierra Leone, Libreville, and Nairobi.

The comparative study relied on locality, age, gender and financial income as main indicators to discern the effects of the pandemic on the nationals of the six African cities and thus to put forward key policy recommendations to counter the social consequences of Covid-19. The study recommends the establishment of additional safety measures to reduce levels of fear relating to COVID-19, the provision of more direct support to youth during the pandemic, the improvement of the public's trust in various levels of government and the police, the improvement of access to COVID-19 testing, the development of courses of action to reduce experiences of discrimination and lastly additional research and continuous surveying.

A.3 Contribution to the organization of the 2021 Pan-African Forum for the Culture of Peace (Luanda, Angola)

The Assistant Director General of UNESCO for Priority Africa and UNESCO's External Relations, Mr. Edouard Matoko expressed to OCPA his wish to see him contribute to the technical organization of the second edition of the Pan-African Forum for culture of peace planned for Luanda in Angola during the year 2021.

A.4 AUC online workshop for the validation of the revised Cultural and Creative Industries Plan (March 31 and April 1, 2021)

The African Union Commission has convened an Online Workshop for March 31 and April 1 to validate the revised Cultural and Creative Industries Plan. OCPA was invited to this meeting and is involved in its preparation.

The same is true of CELHTO, the Center for Historical Studies and Oral Traditions of the African Union, which invited OCPA to participate in an online validation workshop for its Statutes scheduled for April 9 in Niamey. The OCPA Executive Director will take part.

A.5 Participation in technical negotiations of experts from the Region at the initiative of ECCAS

Throughout the week of March 22-26, OCPA participated in technical negotiations initiated with various experts from the Region at the initiative of ECCAS (Economic Commission of Central African States). These discussions focused on the cultural strategy of the Commission, the Conference of Ministers of Culture of Central Africa, the priority programs among which the preparation of the Second Biennial of Culture in Luanda and the technical tools for Participation in technical negotiations of experts from the Region at the initiative of ECCAS throughout the week of March 22-26,

OCPA participated in technical negotiations initiated with various experts from the Region at the initiative of ECCAS (Economic Commission of Central African States). These discussions focused on the cultural strategy of the Commission, the Conference of Ministers of Culture of Central Africa, priority programs including the preparation of the Second Biennial of Culture in Luanda and technical support to the African Union for the special year 2021.

A.6 First CERAV Board of Directors (Bobo Dioulasso, March 30, 2021)

Finally, the Regional Center for Performing Arts in Africa, CERAV-Africa, convened its first Board of Directors for the year 2021 on March 30 in Bobo-Dioulasso. OCPA, which is a member, will be represented by its Executive Director.

A.7 Regional workshop on the contribution of festivals to the development of the film industry and the resilience of the culture sector in Africa in the context of Covid-19

CERAV also announced the organization in Ouagadougou, from April 20 to 23, of a regional workshop on the contribution of festivals to the development of the film industry and the resilience of the culture sector in Africa in the context of Covid-19. Mr. Lupwishi Mbuyamba who will take part to deliver the orientation speech of the meeting.

A.8 World Communities' Virtual Forum 2021: Global Communities Alliance

As part of partner organization collaboration, OCPA took part in the Virtual 2021 World Communities Forum organized by the Kenyan SHOFCO "Sharing Hope for Communities" movement. With the contributions of numerous worldwide community-based practitioners, organizations and partners, the WCF succeeded to delve into the mission of strengthening communities during the current pandemic, and to form the global alliance of communities for the goal of bridging the gap between the leaders and the people as well as their involvement in the problem-solving process and thus to bring a community-based perspective to the global development agenda.

The two days program raised questions about a variety of issues of interest to community activism: Minorities suffering during the pandemic and cooperating support solutions, the digital: a divide and a chance for community-based initiatives, and the financial downfall, program funding and economic recovery.

The WCF called for action through a policy recommendation to be published eventually to envision a more equitable future for better and equal access to health and wealth. To develop community engagement for the goal of putting equity at the heart of policy relying on advocacy and the deployment of proximate leaders and to maintain resilience and strength in the form of community cooperation and community-led initiatives.

A.9 OCPA Publications

In relation with its research activities OCPA has produced some 25 books and publications such as a strategy document (2004) and a research programme (2007 and 2010) on the cultural indicators of human development in Africa, a book on "African Musics – New Stakes and New Challenges" (with UNESCO, 2005), the Observatory's 1st and 2nd Medium Term Strategy and Plan of Action (2006 and 2011), the Compendium of basic reference texts for cultural policies in Africa (E/F/S, 2006 and 2009), the Guidelines for the Design and Evaluation of National Cultural Policies in Africa (2008 an 2009). The Proceedings of the International Symposium on Policies, Strategies and Experiences in Financing Culture in Africa was published in 2010, the Manual for Training Specialist of Cultural Policy and Management in Africa and the book on the Contribution of Culture to Poverty reduction in Africa were produced in 2013. More recently, in 2019, OCPA published with the support of UNESCO a book entitled Intercultural and Interreligious Dialogue: An African Experience as well as the book prepared and published with the support of Africalia on "Anticipating Cultural Policies in Africa by 2030".

B.1 Tunisia: First Art Biennial - A grandiose exhibition under the theme of Pop Art for charitable actions

The Art Biennale is an exhibition under the theme of "Pop Art", an artistic movement that touches on various artistic expressions (arts, music, fashion, etc.). The organizers want to make this exhibition a fixed event to be held every two years, in the form of an Art Biennale. The theme chosen for this first edition is the artistic current "Pop Art" appeared in the West at the beginning of the 1950s.

This targeted choice is intended as a means of adding color to the works of artists, after a year marked by difficult economic and sanitary conditions.

The curator of the exhibition, Nadia Zouari, painter, presented the artists who will take part in this event. "More than 120 works by some fifty artists took part in this exhibition, such as Shoof or El Seed, whose work is exhibited in the largest museums in the world".

B.2 Algeria: Meeting in Algiers on Culture as a determining factor in the exercise of citizenship

The Ministry of Culture and Arts launched, in Algiers, the "Forum of the Palace of Culture" (March 2, 2021), a series of interactive debates on the importance of cultural dialogue at all levels of society, by a first meeting on Culture as a determining factor in the exercise of citizenship. Organized at the Palais de la Culture, this first meeting brought together executives from the culture sector and university teachers.

The director of the Higher Institute of Performing Arts and Audiovisual Trades, Mohamed Boukerras, pointed to technological progress, particularly social networks, which revealed differences of views that could lead to feelings of intolerance and rejection between individuals of the same homeland, advocating to remedy it. "Brahim Nouel then addressed the issue of "cultural mobility" and the "efficiency of cultural spaces", stressing the need to "maintain the functionality of these spaces" beyond administrative hours and to "arouse interest" and allow "cultural contacts" through a greater number of visits.

B.3 Festival Rencontres Recreatrales

Initiated in 2002, the Récréâtrales process is a pan-African space for theatrical writing, creation, research and dissemination.

It brings together more than 150 artists, authors, directors, scenographers and actors, around artistic residencies organized in Gounghin, within the family courts of Bougsemtenga, a popular district of historical importance. Its objectives are to multiply, consolidate, professionalize and diversify the creative approaches of the contemporary African theater scene while promoting the economic and social development of the neighborhood where the project is located.

In addition, the Récréâtrales offer opportunities for artists, with artistic residencies allowing professionalization in all theater disciplines. The festival is an important networking opportunity for artists, programmers, as well as administrators, and is a much anticipated showcase for new African talent.

Since 2002, more than 1000 African, European and Caribbean artists have taken part in the festival, around sixty shows have been created and around forty of them have been extended following the festival in various tours, in Africa and elsewhere. The next edition of the Festival is scheduled for 2022.

C.1 DRC Congo: Culture - Why has the Prime Minister only received two artistic corporations?

March 5 - Instead of consulting the Collectif des Artistes et des Culturels, which is an Association bringing together Congolese artists from all disciplines, Prime Minister Sama Lukonde preferred to receive, on March 1, 2021, two artistic corporations: those of actors and musicians.

The drama is that the musicians presented only the demands of their own sector sector. Fortunately, the comedians gave the Prime Minister with the concerns of all artists and cultural operators. In this document, the Collective has detailed the profile of the new minister of culture. On behalf of all artists working in the country or abroad, the Collective demands that this highly strategic position be entrusted to a cultural professional, mastering the workings of the Congolese cultural sector in order to promote better national cohesion in its diversity, and promote the influence of the DRC at the international level.

Considering culture as a sector as important as mining, the CAC wishes a significant improvement in the budget allocated to the Ministry of Culture and the Arts. Based on the recommendations of the 2nd "Cultural Forum" held in October 2020 and the previous meetings on culture, the ACC recommends the urgent establishment by parliament of a cultural policy.

C.3 Ethiopia: The Problems of Book Publishing in Ethiopia - Different Perspectives

6 March 2021 - A study published in the International Information and Library Review, the author of the article Metikou Ourgay writes about the history of publishing in Ethiopia between 1500-1900 saying that, "During this period numerous ecclesiastical and a few original works by Ethiopians and foreigners had appeared in Ge'ez and in other dialects.

According to historical records, modern publishing started in the 19th century, during the time of Emperor Menelik while it gathered speed under the rule of Emperor Haile Sellassie who

established the first modern printing house, otherwise known as Berhanena Selam printing press in 1914, thereby opening a new era.

The study points out that in 2017 there were more than 125 companies that printed and published books in Ethiopia. This is not obviously too many in a country of more than 110 million people, with a literacy rate of more than 40% and a history of book printing that goes back 600 years.

The Ethiopian publishing industry is still caught in a vicious circle as it was many decades back.

The country is still unable to produce most of the inputs of the industry, such as paper pulp, inks and this often pushes the cost of printing higher eyond the reach of the average reader.

The book production-distribution-consumption chain is still controlled by a handful of quasi monopolistic enterprises who often fix the price of books, apparently constrain the growth of the industry.

C.5 The geography of African artistic heritage in the world today

Bénédicte Savoy, February 12, 2021 - In 2018, together with the writer and economist Felwine Sarr, the art historian Bénédicte Savoy submitted to the President of the Republic a report on the possible restitution of African cultural heritage looted during the period colonial.

As it stands today, the world geography of the tangible heritage of ancient Africa is inextricably linked to that of the occupation of the continent by European states in the 19th and 20th centuries. The British Museum's inventories count 69,000 objects from Africa south of the Sahara. The Weltmuseum in Vienna 37,000. The Royal Museum for Central Africa in Tervuren, Belgium 180,000.

The Nationaal Museum van Wereldculturen in the Netherlands 66,000, the ethnological museum of Berlin 75,000 and that of the quai Branly-Jacques Chirac in Paris almost 70,000. Alone, the large museums of Paris, Berlin, London, Brussels, Vienna, Amsterdam and Leyden concentrate half a million African pieces.

D.2 Creative Europe: 2.2 billion EUR support secured for artists

In December 2020, the European Parliament and Council agreed on the next 'Creative Europe' programme (2021 – 2025), making the biggest ever commitment to support EU cultural and creative sectors.

'The new programme is excellent news for the European cultural and creative sectors. We were able to secure more funds for the cultural and creative sectors and can now provide 2.2 billion EUR in support, more than ever before. This is not only a symbolic recognition of the importance of culture, but will allow us to finance more projects and help the sector recover from the consequences of the COVID-19 pandemic', said the Chair of Parliament's Culture and Education Committee, Sabine Verheyen (EPP,DE).

During the negotiations, MEPs insisted that that more will be done to support the music sector, particularly areas of contemporary and live music. These will be covered by the funds for 'Culture', which support, inter alia, platforms that promote emerging artists and networks that assisting with transnational distribution.

Though many authors, professionals, teachers and artists are female, they are much less likely to occupy decision-making positions in cultural, artistic and creative institutions. MEPs therefore inserted an obligation for the programme to promote female talent and support women's artistic and professional careers.

The commitment to foster gender equality is now one of the main values to be pursued by 'Creative Europe' projects. Furthermore, when selecting experts to evaluate project proposals, due consideration will need to be paid to gender balance. One of the key objectives of the new programme will be to promote access for and the participation of disabled people and socially marginalized groups in the creative and cultural sectors, both as creators and audience members.

D.3 The Netherlands develop various modes of return of museum artefacts

The Dutch government has become the first in Europe to approve a central mechanism for repatriating colonial loot. It pledged to return unconditionally any objects in the national collections found to have been stolen from former Dutch colonies. Moreover, a research consortium of nine museums and Amsterdam's Vrije Universiteit is preparing a practical guidance for museums on colonial collections. "We will examine the diverse routes that objects took to enter museums?", says Wayne Modest of the National Museum of World Cultures. With Susan Legêne, dean of the faculty of humanities at the Vrije Universiteit, he is the leader of the project. "We will also look at how to jointly decide on the future of an object and whether there are various modes of return that are possible. And, finally, this is about reconciliation - how do modes of return or restitution help us to reconcile with the past?".

F.1 News from the International Federation of Arts Councils and Cultural Agencies (IFACCA – ACORNS)

Efforts for combating thenegative effects of the pandemia on Culture and arts

The March 2020 issue of ACORNS was our first to address global responses to COVID-19 in the arts and culture sector. One year later, the headlines reflect the ongoing efforts of national governments and international actors worldwide to support and revive the arts and culture sector in the context of the pandemic, and to gauge and communicate its effects. In recent weeks, several countries (Canada, Chile, Guyana, Ireland, Singapore, Sweden, USA, England, Scotland) have announced significant national investment in arts and culture. Recent headlines also highlight the need to gauge and communicate the effects of the pandemic on the sector; and to implement clear, informed and collaborative paths out of crisis. In South Africa, the Minister of Sport, Arts and Culture, Nathi Mthethwa has set up a Ministerial Advisory Team for the creative and cultural sector which will advise on COVID-19 responses, focussing on five workstreams that reflect related portfolios including: banking and landlords; wellness; school fees; retail and transport; and the private and corporate sector. At an international level, UN Special Rapporteur in the field of cultural rights, Karima Bennoune presented a special report to the 46th session of the Human Rights Council – COVID-19, Cultures and Cultural **Rights** – which surveys the effect of the pandemic on culture and cultural rights, outlines their positive potential and makes recommendations for action, including to increase funding in the culture sector; and the European Parliament has published Cultural and creative sectors in post COVID-19 Europe, which looks at the effects of the crisis on the sector.

Le numéro de mars 2020 d'ACORNS a été notre premier à aborder les réponses mondiales au COVID-19 dans le secteur des arts et de la culture. Un an plus tard, les gros titres reflètent les efforts continus des gouvernements nationaux et des acteurs internationaux du monde entier pour soutenir et relancer le secteur des arts et de la culture dans le contexte de la pandémie, et pour mesurer et communiquer ses effets. Ces dernières semaines, plusieurs pays (Canada, Chili, Guyane, Irlande, Singapour, Suède, États-Unis, Angleterre, Écosse) ont annoncé d'importants investissements nationaux dans les arts et la culture. En Afrique du Sud, le ministre des Sports, des Arts et de la Culture, Nathi Mthethwa a mis en place une équipe consultative ministérielle pour le secteur créatif et culturel qui donnera des conseils sur les réponses au COVID-19, en se concentrant sur cinq axes de travail qui reflètent les portefeuilles connexes, notamment: les banques et les propriétaires; le bien-être; frais de scolarité; vente au détail et transport; et le secteur privé et des entreprises. Au niveau international, la Rapporteuse spéciale des Nations Unies dans le domaine des droits culturels, Karima Bennoune a présenté un rapport spécial à la 46e session du Conseil des droits de l'homme - COVID-19, Cultures et droits culturels - qui examine les effets de la pandémie sur la culture et droits culturels, souligne leur potentiel positif et formule des recommandations d'action, notamment pour accroître le financement du secteur culturel; et le **Parlement européen** a publié Secteurs culturels et créatifs dans post COVID-19 Europe, qui examine les effets de la crise sur le secteur.

USA - Taking Note: The Social Determinants of Arts Engagement

Last week, researchers posted an article titled "Who engages in the arts in the United States?" The analysis is part of a long-term project by the NEA (National Endowment for the Arts) Research Lab at the University of Florida's Center for Arts in Medicine.
